Under Section 19(1)(d) of the Immigration Advisers Licensing Act 2007 (the Act), a licence will be granted **if**, amongst others, the Registrar is satisfied that the application complies with section 18 and is properly completed.

- A criminal record history/ PCC is required for each country you have lived in the last 10 years for one year or more.
- A criminal record history/ PCC must not be expired, and it must be not have been issued more than 6 months ago.
- A criminal record history/ PCC must be issued with all names by which you are known. These should also be listed in your application form. If this is not possible, please provide a statutory declaration stating that you are known by those names, you are unable to have them included in your criminal record history or PCC, and that you have no convictions in that country under those names.

Section 66 of the Act provides that it is an offence to provide a false or misleading information to the Authority. Furthermore, under Section 27(1)(b) of the Act, the Registrar must cancel a licence if he or she is satisfied that the licence was granted on the basis of any false or fraudulent representation or declaration, made either orally or in writing.
